

## Network Management

Region 1 Behavioral Health Authority assists in developing, implementing and evaluating regional behavioral health service needs, outcomes, and programs to ensure that the behavioral health system operates in an effective and coordinated manner. Region 1 BHA manages a network of community-based provider organizations and community coalitions that provide a variety of behavioral health services from prevention to inpatient care and all levels of care in between. Region 1 BHA implements minimum standards for behavioral health providers, manages provider enrollment, determines the capacity necessary to provide a balanced behavioral health service array and provides technical assistance to providers as needed. Region 1 BHA is accountable for all sources and expenditures of public funds (federal, state and county) administered through the Region and utilizes contract monitoring, the tracking of outcomes, and fiscal audits and programmatic reviews of network providers to ensure the effective and efficient utilization of public resources.
